Liability, Insurance, and Indemnification. Community Exhibitor accepts full responsibility for its operation on the Festival of Mountain and Plain ... A Taste of Colorado ("A Taste of Colorado" or the "Festival") site, including the time of the transportation to and from the site, set-up, tear-down, and operation at the event; and will provide insurance coverage as provided below. On or before July 15, 2017, COMMUNITY EXHIBITOR will furnish Downtown Denver Events, (DDE) a certificate of insurance as required below and carried by COMMUNITY EXHIBITOR with a financially responsible insurance company satisfactory to DDE. Said certificate will specifically name:

DOWNTOWN DENVER EVENTS, INC.; DENVER CIVIC VENTURES; INC.; DOWNTOWN DENVER PARTNERSHIP, INC.; DOWNTOWN DENVER, INC.; DEAN MENOS; EVENT MANAGEMENT GROUP; CITY AND COUNTY OF DENVER; STATE OF COLORADO; and each of DDE's affiliates and respective board members, officers, employees, agents, volunteers, and subsidiaries

as additional insured's for damages which may be sustained as a consequence of COMMUNITY EXHIBITOR's exercise of its obligations at the Festival, with the limits of liability not less than those indicated below. Said policy shall provide that such insurance shall not be canceled or changed in any material way except upon thirty (30) days prior written notice to all parties. Said insurance policy must be in effect from August 20, 2017 through September 10, 2017. The types of insurance required and the minimum limits are as follows:

- **General and Product Liability.** Bodily injury and property damage insurance in the amount of not less than \$1,000,000 combined single limit.
- **Automobile Liability.** Bodily injury and property damage insurance in the amount of not less than \$500,000 combined single limit.
- **Worker's Compensation.** Statutory worker's compensation insurance as required by the State of Colorado and Employer's Liability insurance in the amounts of \$100,000 / \$500,000 / \$100,000.
- **COMMUNITY EXHIBITOR's Property.** COMMUNITY EXHIBITOR must insure its equipment against loss, theft, and damage while the equipment is on the A Taste of Colorado site and while the equipment is in transit to and from the A Taste of Colorado site. Downtown Denver Events, Inc., Downtown Denver Partnership, Inc.; Downtown Denver, Inc.; Denver Civic Ventures, Inc.; the City and County of Denver; State of Colorado; Dean Menos; Event Management Group; and its subsidiaries and all of its respective board members, officers, agents, volunteers, and employees assume no liability for loss, theft, or damage to equipment owned, rented, leased, or borrowed by COMMUNITY EXHIBITOR or its agents.

COMMUNITY EXHIBITOR agrees to indemnify, defend and hold harmless DOWNTOWN DENVER EVENTS, INC.; DENVER CIVIC VENTURES; INC.; DOWNTOWN DENVER PARTNERSHIP, INC.; DOWNTOWN DENVER, INC.; DEAN MENOS; EVENT MANAGEMENT GROUP; CITY AND COUNTY OF DENVER; STATE OF COLORADO; and each of DDE's affiliates and respective board members, officers, employees, agents, volunteers, and subsidiaries against any and all claims, liabilities, damages, costs, and expenses (including reasonable attorney's fees) which are occasioned directly or indirectly by COMMUNITY EXHIBITOR's operations, including without limitation, injury or damages to persons or property which may result from the actions of COMMUNITY EXHIBITOR, its agents, and employees. The term "agents and employees of COMMUNITY EXHIBITOR" shall be deemed to include, but is not limited to, all operators, employees or representatives thereof and all parties with whom COMMUNITY EXHIBITOR contracts for the production, and/or operation of their booth at the Festival.
